Recent CAT Website Updates

- Updated Industry Member Test Environment Known Issues List
- Updated FAQ <u>D4</u> regarding origination of a discretionary order with new Phase 2c requirements for reporting allocation events
- New FAQs
 - **F7** regarding order level and fulfillment level linkage on a representative order
 - N6 regarding third party reporting agreements
 - **<u>B48</u>** regarding origination of proprietary equities orders

IM Reporting Scenarios

- ► IM Reporting Scenarios v3.1 was published on 4/7 with two new Child Order scenarios.
 - Industry Member Generates a Representative Order then Creates a Child Order –
 firmDetails on the MEOF should reflect the Order ID of the representative order.
 - Industry Member Creates a Child Order then Generates a Representative Order -Based on Broker 1's order handling practices and system architecture, the firm may populate either the *orderID* of the parent order or the related child order in the *clientDetails*.

CAT Alerts 2018-03 and 04

- Updated <u>CAT Alert 2018-003</u> pertaining to IMID usage for CAT data submissions; this alert will be retired and its content will be incorporated into the Tech Spec.
- Retired CAT Alert 2018-004 and added new document <u>Order Routing</u> <u>Field Correlations between CAT and Exchanges.</u> This document is published on the Technical Specifications page.

IM Tech Spec v2.2.1 r4

- V2.2.1 r4 of the IM Tech Spec is planned for publication on April 21st, 2020. This publication will include content from the IM Tech Spec Update List (next slide).
- ▶ A companion V3.1.0 r2 will be published to incorporate the same updates.

Porting of ATS Order Types and CRA Relationships

- ATS Order Types entered into the Test Environment before April 12 will be ported into Production Environment on April 13. Porting of ATS Order Types will only occur once.
- ▶ CRA Relationships for firms certified by **April 3** will be ported to the Production Environment. FINRA CAT is analyzing the possibility of doing a second porting for firms certified after **April 3**.
