EXECUTIVE SUMMARY

In accordance with Section 6.6(c)(i) of the CAT NMS Plan, the Participants provide this Implementation Plan, which includes the Participants' timeline for achieving the objective milestones setting forth how and when the Participants will facilitate the achievement of Full Implementation of CAT NMS Plan Requirements. The Implementation Plan includes the targeted or actual completion date and a description of the status for each of the objective milestones set forth in Section C.10 of Appendix C of the CAT NMS Plan and for each of the Financial Accountability Milestones, as defined in Section 1.1 of the CAT NMS Plan. Where the Participants decide to complete any of the milestones identified in the Implementation Plan by releasing functionality in a phased approach, the Implementation Plan describes each phased release necessary to achieve the completion of the relevant milestone and provides completion dates for each such release identified.

As of the date of filing of this Implementation Plan, the Participants have satisfied various milestones set forth in the CAT NMS Plan. Among other things and as described in more detail below, the Participants have selected a Plan Processor. In 2018, the Participants commenced reporting Participant Data to the CAT. Other Data (which, pursuant to the CAT NMS Plan includes, but is not limited to, SIP quote and trade data, OCC data, trade and quote information from Participants and reference data) is being reported to the CAT. Participants and Industry Members are subject to requirements regarding synchronization of their Business Clocks. The Participants have published Industry Member Technical Specifications for Phases 2a, 2b, 2c and 2d. In addition, as of June 22, 2020, Large Industry Members and Small Industry OATS Reporters commenced reporting Phase 2a Industry Member Data to the CAT. Large Industry Members commenced reporting Phase 2b Industry Member Data to the CAT on July 20, 2020. These completed milestones and the additional milestones necessary to complete the implementation of the CAT are set forth below.
