# Compliance Error Rate Calculation

- Effective October 26, 2020, the Daily Compliance Error Rates on the Reporter Portal Reporting Summary screen are calculated as follows:

- The records counted in the numerator of the Daily Compliance Error Rate are a distinct count of Events. For example, if a record that is reported late has an out of sequence event and an interfirm unlinked event, then it will be counted only once in the Daily Compliance Error Rate.
- Named Errors do not participate in Compliance Error Rate.

# Observations with Differences in Interfirm Linkages Key

---

The following scenarios are generating unlinked events and have been observed across many firms:

1. Firms populating the *orderId* as the *routedOrderID*; Counterparty reporting another value
2. Firms populating prefix in *routedOrderID*
  - Firms populating prefix: FIRMA *routedOrderID* = **XXX**123ABCD;  
FIRMB *routedOrderID* = 123ABCD
3. Firms populating suffix in *routedOrderID*
  - Firms populating suffix: FIRMA *routedOrderID* = 1111**ABCD**;  
FIRMB *routedOrderID* = 1111
4. Firms submitting MENOs instead of MEOAs
5. Sender and Receiver populating different IMIDs
6. Firms improperly marking an Exchange Route as an Interfirm Route

# OTC Equity– Foreign Routes Planned IM Tech Spec Update

---

- Add a new destinationType to the IM Tech Spec ‘O’
  - This value would be used in instances where an order in an OTC equity symbol for a foreign security was routed to another Industry Member, who may route the order to a foreign market for execution and does not report the order CAT while the sending firm did report it to CAT.
- **Update from last week:** Add a new senderType value of ‘O’
  - This value would be used in instances where an order in an OTC equity symbol for a foreign security was received by an Industry Member with instructions to only execute in a foreign market and the Industry Member voluntarily reports it to CAT while the routing firm did not report it to CAT.
- Value of ‘O’ is only permitted for OTC equity securities
- When ‘O’ is populated as either the destinationType or senderType, if a corresponding *routedOrderID* is found, linkage will be made. If no corresponding *routedOrderID* is found reported by the sending/receiving party, linkage feedback will not be returned.
- Implementation date is to be determined.

# Observations with Differences in Exchange Linkages Key

---

The following scenarios are generating unlinked events and have been observed across many firms:

1. Firm populating incorrect Exchange ID in destination field.
2. Industry Member and Exchange populating different IMIDs.
3. Session IDs incorrectly populated.
4. Firms improperly marking an Exchange Route as an Interfirm Route or reporting routing to an exchange when the order was routed to another Industry Member (such as a floor broker).
5. Routed Order IDs do not match.

Other linkage items:

- Firms are getting named errors from NASDAQ option exchanges due to an internal system route happening at the exchange. The original routing party is being sent on the internal route event, so FINRA CAT is attempting linkage. NASDAQ and FINRA CAT are working to resolve this issue.

# Blanks, Leading Zeros and Special Characters

- Leading zeroes
  - Leading zeroes are removed at ingest from fields that are data type 'Numeric'
  - Leading zeroes are removed from the routedOrderID and session fields at time of Route Linkage Key construction
- <Blank> Characters
  - Leading and trailing <blank> characters are removed at ingest from fields that are data type 'Text' and 'Alphanumeric'
  - A <blank> character in the middle of the routedOrderID and session fields is NOT removed. For example, if an Industry Member submits "ABC 123" and the Exchange submits "ABC123" an unlink error will occur.
- Firms should take note of each exchange's interface specifications regarding special characters or spaces, as some exchange transmission protocols may remove certain characters or spaces. This field must match the value for routedOrderID reported by the exchange in their Order Accepted event.
- Feedback files will NOT contain FINRA CAT alterations to 'Text' and 'Alphanumeric' fields made during Route Linkage Key construction. For example, when researching the following linkage error, Industry Members should note the leading zero was removed during the linkage process and the error is related to the special character.

# Observations with Differences in TRF Linkage Key

---

The following scenarios are generating unlinked events and have been observed across firms. The Industry Member is:

1. Populating a different CATReporterIMID on the MEOT than in the TRF/ADF/ORF report.
2. Populating an incorrect Reporting or Contra Branch Sequence Number or Compliance ID.
  - Have seen instances where in cross scenarios, firms are putting a “B” or “S” in front of the Branch/Seq, etc. in the TRF report (to facilitate OATS) but are reporting the Tape Trade ID on the MEOT without the “B” or “S” prefix.
  - Have seen instances where the Reporting Industry Member populates the Contra Branch Sequence Number or Compliance ID when it is not on that side of the trade report (e.g., the CATReporterIMID is on the Reporting side while the *tapeTradeID* is on the Contra side).
3. Populating an incorrect Market Center ID.
  - Have seen instances where firms populate the exchange code instead of the TRF code.
4. Reporting a duplicated TRF Linkage Key.
5. Populating the *tapeTradeID* in the *tradeID* field.

# Rejected/Corrected TRF Reports

---

- **Scenario:** A trade was rejected in the TRF/ADF/ORF, and the rejected record was corrected, re-submitted, and accepted.
- Does the firm have an obligation to populate the *cancelFlag* as 'True' in its CAT Trade event?
  - If the CAT Trade event is linked to the corrected TRF report, the *cancelFlag* must be set to '**False**'.
  - If the CAT Trade event was NOT linked to the corrected TRF report, the *cancelFlag* must be set to '**True**'.
- Does the firm have an obligation to correct its CAT Trade event?
  - If the CAT Trade event is linked to the corrected TRF report, the firm does **not** have an obligation to correct its CAT Trade event.
  - If the CAT Trade event was NOT linked to the corrected TRF report, the firm does have an obligation to correct its CAT Trade event.

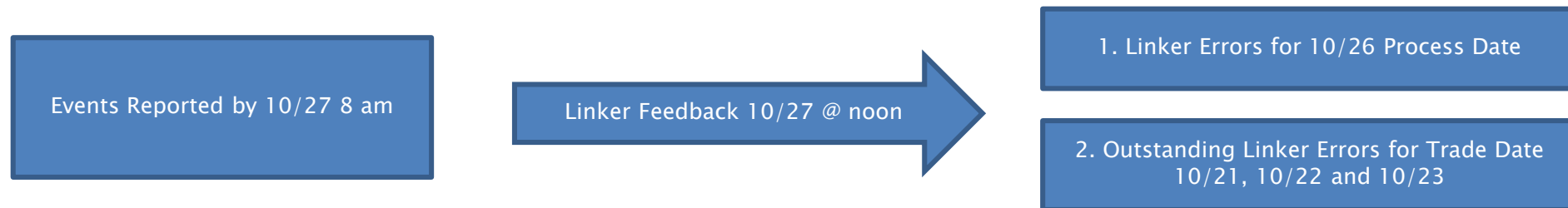

# Outstanding Linker Errors Day 1

---

- Beginning October 26, 2020 a daily outstanding errors file will be delivered in machine readable format available via SFTP and Reporter Portal Download.
- The outstanding errors feedback will include all repairable linker errors (NOT WARNINGS) including named errors that are unrepaired as of a processing date for three prior trade dates.

---

## ➤ Meta Feedback File

- **File Name:** <CAT Submitter ID>\_<CAT Reporter IMID>\_<CAT File Generation Date>\_<File Kind>.linkage\_outstanding[\_<Feedback File Number>].<Format Extension>  
example: SUBID\_MYID\_20170101\_OrderEvents.linkage\_outstanding\_000001.json
- **CAT File Generation Date:** populated with the processing date for which the results represent
- **Populated in the Meta Feedback File**
  - **stageCompleteTimestamp** set equal to date and time when the reconciliation process completed
  - **status** set to 'Failure'
  - **errorCount** set equal to number of outstanding error records for the CAT Reporter IMID on the CAT Processing Date that remain unrepaired for the prior three trade dates

## ➤ Data Feedback File

- **Populated in the Data File**
  - All repairable Linker Errors for the prior 3 Trade Dates that are not repaired after processing data submissions received by 8am of that processing date
  - Warnings are not included
- **When all Linker Errors have been repaired, an Empty File will be delivered:**
  - **File Name:** <CAT Submitter ID>\_<CAT Reporter IMID>\_<CAT File Generation Date>\_<File Kind>.linkage\_outstanding[\_<Feedback File Number>].success

# Ingestion Error Received after Attempted Repair of a Linker Error (1 / 2)

- ▶ IM 1 has an exchange linkage error due to incorrect *session* value
- ▶ IM 1 repairs the session but inadvertently disrupts the *side* value in the repair submission
- ▶ Now IM 1 has both linkage and ingestion errors on the same record

If both the original submission and repair record have the **same firmROEID**, then the IM must submit a 'COR' record with the same firmROEID which will resolve all errors.

# Announcement

## Legal Entity Identifier (“LEI”)

---

- The CAT Transaction Registration Form and CAT CAIS Registration Form both contain a new question asking for a Legal Entity Identifier (“LEI”).
- The CAT NMS Plan requires Industry Members to “submit to the Central Repository” information sufficient to identify such Industry Member “including CRD number and LEI, if such LEI has been obtained.”
- The CAT NMS Plan requirement does not require Industry Members to obtain an LEI, but rather to provide its LEI to the Plan Processor (FINRA CAT) if the Industry Member does have an LEI.
- The collection of the Industry Member’s LEI via the CAT Transaction Registration Form and CAIS Registration Form is separate from the reporting of customer account LEI data requirements.

# Reminders

---

- On June 29, 2020, new versions of the Options Start of Day and End of Day symbol files were introduced to include the Test Option Series flag identifying options test symbols.
- Existing versions of the files without the test flag will continue to be available until December 14, 2020, when they will be retired. Firms that use these files should plan to transition to the new versions prior to that time.
