Phase 2c Cutover Update

- FINRA CAT will support the Phase 2c cutover by providing certain 2a/2b linkage error feedback staged for 2c schema format submission.
 - This was announced during the March 16, 2021 Industry Testing Checkpoint Call

CAT NMS Plan, Exemptive Relief and Interpretive Updates

Exemptive Relief Requests and Orders

• On March 17, 2021, the Plan Participants submitted to the SEC requests for:

- Targeted <u>exemptive relief</u> from the requirement in Section 6.1 of Appendix D that the Plan Processor communicate errors to CAT Reporters by T+1 at noon ET. If granted, from April 26, 2021 through April 29, 2021, the Plan Processor will be able to communicate errors to CAT Reporters by T+1 at 4 pm ET to allow the Plan Processor time to convert data provided to Industry Members from the equities Phase 2a reporting format to the equities Phase 2c reporting format.
- Exemptive relief from the requirement in Section 6.1 of Appendix D that the Plan Processor communicate errors to CAT Reporters by T+1 at noon ET and instead, the Plan Processor would be required to communicate errors to CAT Reporters by T+1 at 4 pm ET. This request amended and replaced in its entirety a similar request previously submitted to the SEC on December 4, 2020.
- Exemptive relief from the requirement in Section 6.1 of Appendix D that CAT Reporters resubmit corrected data by T+3 at 8 am ET and instead, CAT Reporters would be required to resubmit such corrected data to CAT by T+4 at 8 am ET. This request amended and replaced in its entirety a similar request previously submitted to the SEC on December 4, 2020.
- <u>Exemptive relief</u> to move certain Industry Member reporting obligations from Phase 2c to Phase 2d; these items include: (1) rejected external route flags related to the equity leg of a multi leg order; (2) certain OTC Equity Securities quotes; (3) certain OTC Equity Securities messages; and (4) quote identifiers.

New FAQs

- 8 New <u>FAQs</u> published since the last Monthly CAT Implementation Update (February 18, 2021).
 - B72 regarding the Phase 2a/2b reporting obligations for RFQ/solicitation responses
 - J4 regarding the reporting obligations for quotes originated prior to the Phase 2d Go-Live date (December 13, 2021)
 - K15 which illustrates how to populate the *priceType* field on multi-leg events ("per unit", "total strategy" or "total cash")
 - Q39 regarding the address and transformed identifier requirements for an account opened in the name of a Prime Broker for the benefit of a customer
 - Q40 which defines the term "Active Account" and describes the Active Accounts that must be reported to CAIS by July 11, 2022
 - Q41 describes the CAIS reporting requirements for "Active Accounts" with activity that occurs between January 11, 2022 and July 10, 2022.

New FAQs- continued

- U24 regarding when an allocation becomes reportable in multi-prime scenarios when the *DVPCustodianID* is not yet available
- U25 reflects the CAT reporting requirements for allocations originated prior to Phase 2c and Phase 2d Go-Live

Updated FAQs

- 8 Updated <u>FAQs</u> published since the last Monthly CAT Implementation Update (February 18, 2021).
 - A26 was updated to reflect the CAT reporting requirements for orders originated prior to Phase 2c and Phase 2d Go-Live
 - B49 was retired and relocated as FAQ U26
 - B69 was updated to reflect that the 'OFF' handlingInstructions value is required starting in Phase 2d for NAVs with an offset
 - E25 was updated to include a scenario for populating cancel information on an MEOT when the Reporting Exception Code of 'C' is used
 - J2 was updated to reflect that the OTC Link messages are reportable in Phase 2d and related scenarios are available in the Reporting Scenarios document

Updated FAQs- continued

 FAQs Q3, Q20 and Q28 were updated to clarify that only Large Industry Members with FDIDs that have associated LTID/UTLIDs and CAT reportable activity in Phases 2a, 2b and 2c are required to report to CAIS-LTID by April 26, 2021

Technical Specification Updates

- Updated versions of the Phase 2c and Phase 2d <u>Technical Specifications</u> and <u>Reporting Scenarios</u> were published on March 5, 2021.
 - The 2d Industry Member Schema (v4.0.0 r7) was published on March 8, 2021
- An overview of the Technical Specifications updates was presented at the <u>March 9, 2021 CAT Technical Specification Working Group</u>.
