# Phase 2c Cutover Update

---

- ▶ FINRA CAT will support the Phase 2c cutover by providing certain 2a/2b linkage error feedback staged for 2c schema format submission.
- ▶ *CAT Alert 2021-01- Phase 2c Cutover- Transitioning from Phase 2a/2b to Phase 2c Data Submissions* was published on March 23, 2021.



# Linkage Error Transition Support

- Beginning with Processing Date April 23, 2021, for which feedback is delivered by noon on April 26, 2021, linkage feedback will be provided in Phase 2c format.
  - For errors returned in CSV format, new fields applicable to Phase 2c will be represented with a delimiter; no values will be populated in those fields.
  - For errors returned in JSON format:
    - New required non-Boolean field (TIF code on MEOJ event), will be added with a “dummy” value populated. The dummy value will meet the data type requirement but will not be an allowable value that will pass data integrity validations.
    - New required Boolean fields will not be added.
    - New conditional fields will not be added.
