- ▶ v4.0.0 r13 of the <a href="Phase 2d CAT Industry Member Technical Specifications">Phase 2d CAT Industry Member Technical Specifications</a> (Clean and Redlined) were published on January 6, 2022.
- A new document was published on January 14, 2022, 2022 IM Releases Scope and Schedule, which includes: planned schema changes and related validations, publication dates for the related Industry Member Technical Specifications, and the release dates for the Industry Member Test Environment and Industry Member Production Environment.

# New and Updated CAIS FAQs

- One New CAIS FAQ:
  - FAQ Q56 regarding CAIS reporting obligations for Authorized Traders
- Three CAIS <u>FAQs</u> were updated to conform with other published guidance:
  - Q10 answers a question about the *ltidEffectiveDate* field and was updated so that
    it applies to FDID records rather than accounts.
  - Q16 asks if Industry Members are required to submit the same CAIS records daily or only when required data elements change and was updated to include the Full CAIS reporting requirements.
  - Q26 was updated to the include the Full CAIS certification requirements for Reporting Agents.

- A new document was published on January 14, 2022, Full CAIS Industry Member Release Rollout, which details the functionality available in each Release, including the dates that the functionality will be available in the Industry Member Test Environment and Industry Member Production Environment.
- v1.8 of the <u>Industry Member CAIS Onboarding Guide</u> was published on January 12, 2022.

# **Compliance Updates**

#### 2022 Annual Clock Synchronization Certification

- Industry Members must complete an annual certification for Business Clock Synchronization by March 15th of each year.
- Industry Members are not required to submit such certifications to the exchanges or FINRA. Instead, originals of such certifications must be maintained by Industry Members as part of their books and records and be available to regulators upon request. Industry Members who are members of multiple Participants need only make a single clock synchronization certification.

# Industry Member Report Card Updates

- ▶ The December 2021 CAT Industry Member Compliance Report Cards were published on January 15, 2022.
