On June 3, 2022, the Plan Participants submitted to the SEC a <u>request</u> for exemptive relief from certain provisions of the CAT NMS Plan related to the reporting of certain verbal floor activity and unstructured verbal and electronic upstairs activity.

New and Updated CAIS FAQs

Two new CAIS FAQs:

- FAQ Q61 addresses if and when the Industry Member must be identified as a CAT Customer when there are standing instructions on the Customer's account, when the Industry Member originates an order in a Customer's account to satisfy a legal requirement or SEC/SRO rule or when the Industry Member liquidates fractional shares held in a Customer's account to facilitate operational processes.
- FAQ Q62 states that when a clearing firm is reporting its version of the Customer Record, and the *correspondentCRD* field is populated, the clearing firm may report a *role* of 'AUTHREP' for an Authorized Trader rather than "flipping" the *role* to 'AUTH3RD' and a *customerType* of 'EMPLOYEE' rather than "flipping" the *customerType* to 'OTHBKR'.
