Technical Specification Updates


► There were no updates to the Transaction Technical Specifications or Reporting Scenarios document.

Metadata File Reminder

- ▶ For submissions to the Transaction database, effective July 24, 2023 in the Production Environment, the Metadata File submission associated with the Data File will no longer be supported.
 - If a Metadata file is submitted on or after July 24, 2023, it will be rejected at the File Acknowledgement stage of processing.
 - Deployment release will occur around 8 am ET on July 24, 2023. Email notifications will be sent regarding deployment and environment availability.
 - Upon rejection of the Metadata file, no additional action is required by the Industry Member or CAT Reporting Agent. Rejected Metadata files will have no impact on the Industry Member's compliance rate.
- This was discussed during the April 18, 2023 <u>Technical Specifications Working</u> Group.
