  - Interim Reporting Obligation 4: May 24, 2024
    - All outstanding rejections and Material Inconsistences for all CAT reportable activity beginning June 12, 2022 are resolved.
  - Compliance Go-Live: May 31, 2024
    - All error repair and Material Inconsistency resolution deadlines are enforced.

## Material Inconsistencies

- Analysis of the historical Material Inconsistencies scan as of April 24, 2024 reflects that less than 1% (.60%) of unique Customers have an outstanding Material Inconsistency.
  - The analysis also reflects that the vast majority of Material Inconsistencies involve
     YOB with a very small percentage involving EIN and Foreign Customer Type.




