# CAIS Updates

# SEC Order Approving Proposed CAIS Amendment – Background

---

- ▶ On January 13, 2026, the SEC approved [proposed amendments](#) to the CAT NMS Plan related to the Customer and Account Information System (“CAIS”). Among other things, the CAIS Amendment:
  - Permanently eliminates the requirement that Industry Members report customer Names, Addresses, and YOBs to CAT—this change applies to all customers including foreign natural persons and legal entities.
  - Requires the deletion from CAIS of Names, Addresses, and YOBs.
- ▶ The CAIS Amendment builds on the Commission’s February 2025 CAIS Exemption Order, which provided an exemption from the requirement to report Names, Addresses, and YOBs for U.S. natural persons.
  - [CAT Alert 2025-02](#) provided guidance for how Industry Members may elect to discontinue reporting Names, Addresses, and YOBs for Designated Natural Persons, in accordance with the exemption. This guidance remains in effect prior to the implementation of the CAIS Amendment.
- ▶ In December 2025, CAT LLC filed proposed cost savings amendments that would, among other things, eliminate CAIS and adopt a more streamlined approach to generate CCIDs. This amendment has been published for public comment. The comment period ends on January 30, 2026.

# SEC Order Approving Proposed CAIS Amendment – Implementation

---

- ▶ In approving the CAIS Amendment, the Commission recognized that it may be appropriate to extend the implementation schedule in light of the pending cost savings amendment, which, if approved by the SEC, could require the Plan Processor to make further changes to CAIS and Industry Members to make further changes to their reporting systems.
- ▶ A primary goal is to avoid duplicative costs to CAT Reporters. With that in mind, the Participants are working with FINRA CAT to evaluate cost-effective options to implement changes pursuant to the CAIS Amendment in a manner that considers the additional changes that would need to be made if the SEC approves the cost savings amendment.
- ▶ We will keep Industry Members apprised as more details develop with respect to the implementation plan for the CAIS Amendment.
